### 2. Details of the Contest

No purchase is necessary to enter or win.

Date: from July 5th, 2019 to July 10<sup>th</sup>, 2019 (French date and time).

Campaign Period: Entries will be accepted online starting on July 5th, 2019 (French time) and ending July 10<sup>th</sup>, 2019, 11: 59 p.m. (French time).

You may enter only once. You must provide the information requested.

You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules.

If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Quiltmania Editions.

## **5. Winner Selection and Notification:**

The 5 Winners will be selected by a random drawing on July, 11<sup>th</sup> 2019.

Winners will be notified by personal message on Facebook within three (3) days following selection of Winners and will be asked to provide their mail address in order to receive their prize.

Quiltmania Editions shall have no liability for Winner's failure to receive notices due to spam, junk e-mail or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information.

If Winner cannot be contacted, is ineligible, fails to claim the prize within 7 (7) days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected. The prize is nontransferable. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of Winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by Winner is permitted.

Acceptance of prize constitutes permission for Quiltmania to use Winner's name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.
